

RESOLUTION NO. 3635

**RESOLUTION OF THE CITY COUNCIL OF THE CITY OF MONTE SERENO
DECLARING CANVAS OF RETURNS AND RESULTS OF GENERAL MUNICIPAL
ELECTION HELD NOVEMBER 8, 2016**

WHEREAS, a General Municipal Election (hereinafter the “Election”) was held in the City of Monte Sereno (“City”) on November 8, 2016, in accordance with the law, and the votes thereat received and canvassed, and the returns thereof ascertained, determined and declared in all respects as required by law; and

WHEREAS, the results of said election have been duly certified by the Registrar of Voters for the County of Santa Clara and the results of the certification forwarded to the City.

NOW THEREFORE, BE IT RESOLVED, by the City Council of the City of Monte Sereno, as follows:

1. The City Clerk of the City be and she is hereby directed to enter this Resolution in the minutes of this Council as a statement of the result of said election.
2. The total number of ballots cast in the City at said Municipal Election was Two Thousand Two Hundred and one (2201) ballots.
3. The list of candidates nominated for the offices to be filled at the Election and the names of each candidate which were set forth in the petition assembled and filed with the City Clerk, as required by law, and the number of votes cast in favor of each candidate was as follows:


